New Village Girls Academy has meaningfully consulted with its community members on an ongoing basis through the development of numerous plans mandated by the CDE since Spring 2020 and most recently the development of the school's LCAP, AB86 Expanded Learning Opportunities Grant, and the development of the ARP/ESSER III Expenditure Plan. As a result of the COVID-19 pandemic, and in adherence to California State and County Health Department Health & Safety Guidelines, Consultation took place virtually via Zoom meetings, and through online surveys with numerous types of community members.

NVGA's Principal presented various types of schoolwide data including analysis from student assessment data, Annual Measurable Outcomes as required in the LCAP, participation and attendance rates especially with distance learning, and survey results. The discussion and analysis of these data points was both instrumental and the starting point in developing meaningful consultations with community members, that focused on data-driven decision-making for allocating our school's ESSER III funds.

Consultation through Community Engagement included the School's Administration, Special Education Administrator, Teachers, paraprofessionals, EL Coordinator, Homeless/Foster Youth Liaison, families, students, and Community-based organizations that have partnered with New Village Girls Academy. These partnerships include but are not limited to: Heluna Health/Gang-Reduction Youth Development (GRYD), Bet Tzedek Law Firm, Mexican Consulate in Los Angeles, Critical Mass Dance Company, Wildwood School, USC Physician's Assistant Pipeline, USC, California Science Center, St. Anne's Maternity Home, St. John's Well Child & Family Center, and the Advot Project which include advocates representing homeless students, foster youth, migratory students, and other underserved students.

Discussions with the Leadership Team took place during weekly meetings and planning meetings for the 2021-22 school year and included the Special Education Administrator. Consultation with teachers, paraprofessionals, and school staff, took place during morning circles staff meetings, during Summer Professional Development, and bi-weekly staff meetings.

Meaningful consultation with students took place via surveys in both English and Spanish since our school has identified “newcomer” English Learners.

Consultation with Parents/families took place via ELAC, Parent Advisory Committee (PAC), Parent meetings, Principal Office Hours, and online surveys administered in English and Spanish. Interpreter services were made available at every meeting, led by our bilingual staff and Principal. As with all correspondence, all materials sent to families were provided in English and translated to Spanish, as identified by our (primary) language survey and the “15% and above translation needs” CDE criteria; and written in a language that is understandable and accessible to parents. Accommodations as appropriate were also made for family members with disabilities including providing information and school reports in a format (to the extent practicable) in a language that parents understand.

New Village Girls Academy evaluated its stakeholder engagement opportunities and determined that the following community members/groups are neither present nor currently served by our school: Civil Rights Groups, Disability Rights Groups, Tribes, and Individuals or advocates representing the interests of children with disabilities, English learners, children who are incarcerated.

The development of the various aspects of the school’s ESSER III Expenditure Plan was influenced by the input and feedback of the numerous and ongoing meaningful consultations gathered through community input.

The School’s Leadership identified the following needs:

- After-school enrichment program to further accelerate learning and support student needs
- Expand access to address student Mental Health needs
- Continue to identify and establish partnerships with Community-based Organizations that support the needs of our student
- Additional PPE & Cleaning supplies as a result of COVID-19 and return to in-person daily instruction

Special Education Administration identified the following needs:

- Addressing social-emotional and mental health needs of students
- After-school program to support students, impact of lost instructional time

Teachers, paraprofessionals, and staff identified the following needs:

- Technology needs: Laptops, wi-fi hotspots, projectors
- After-school enrichment program

Student survey results revealed the following priorities:

- Purchase of PPE, cleaning supplies to maintain a safe in-person learning environment
- Purchase of additional technology devices and wi-fi hotspots
- Providing additional online educational platforms
- Mental health and social-emotional services
- Providing after-school enrichment and support
- Providing Summer School to accelerate learning and credit recovery

Input and feedback from families revealed the following priorities:

- Providing after-school academic support and enrichment – concerns with learning loss
- Providing mental health services and support
- Purchase additional technology devices for at-home use and Wi-fi Hotspots (lack of connectivity)

Community-based Organizations/Community Partners suggested the following:

- Offering after-school programming/extended learning opportunities
- Expand Social-emotional & Mental Health services
- Continue ongoing communication via Community Resource Coordinator to identify schoolwide/student needs and establish partnerships that support the school's mission and vision.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;
